NO TRASH OR RECYCLING SERVICES ON THURSDAY, NOVEMBER 23, 2017. THURSDAY SERVICES (TRASH AND RECYCLING) WILL INSTEAD BE PROVIDED ON SATURDAY, NOVEMBER 25, 2017.

CHRISTMAS DAY (MONDAY)

NO TRASH SERVICE ON MONDAY, DECEMBER 25, 2017.

TRASH SERVICE WILL RESUME ON THE NEXT REGULARLY-SCHEDULED DAY, THURSDAY, DECEMBER 28, 2017.

NEW YEAR'S DAY (MONDAY):

NO TRASH SERVICE ON MONDAY, JANUARY 1, 2018.

TRASH SERVICE WILL RESUME ON THE NEXT REGULARLY-SCHEDULED DAY, THURSDAY, JANUARY 4, 2018.

CHRISTMAS TREE COLLECTION:

CHRISTMAS TREES WILL BE COLLECTED ON WEDNESDAY, JANUARY 3, 2018, AND WEDNESDAY, JANUARY 10, 2018. ALL DECORATIONS AND TINSEL MUST BE REMOVED. DO NOT PLACE TREES IN PASTIC BAGS.

REMINDERS:

ALL UNITS ARE REQUIRED TO USE A TRASHCAN(S), WITH A SECURE LID, AND WITH THE UNIT NUMBER ON THE TRASHCAN(S).

TRASH MAY NOT BE LEFT OUT FOR PICK-UP IN TRASH BAGS.

TRASHCANS MAY BE PLACED OUT AFTER 8:30 PM THE NIGHT BEFORE PICK-UP. RECYCLING IS PICKED UP ON THURSDAYS ONLY! RECYLING BINS MAY BE PLACED OUT AFTER 8:30 PM THE NIGHT BEFORE PICK UP. RECYCLING MUST BE CLEAN AND FREE OF FOOD RESIDUE. IF YOU PLACE ANY RECYCLING OUT ON MONDAY IT GOES IN THE TRASH AND IT MUST BE PLACED IN YOUR TRASHCAN!

TRASHCAN(S) AND RECYCLING BINS MUST BE REMOVED ON THE DAY PICK-UP

ALL BACK YARD TRASH MUST BE IN A TRASHCAN(S) WITH A SECURE LID. RANDOM INSPECTIONS WILL BE CONDUCTED.

LARGE ITEMS, SUCH AS BUT NOT LIMITED TO, FURNITURE, DRYWALL, PLYWOOD, ETC., DOES NOT HAVE TO BE PLACED IN A TRASHCAN(S).

AN APPLIANCE SUCH AS WASHERS, DRYERS, STOVES, ETC., REQUIRES THAT YOU CALL PATRIOT DISPOSAL @ 703-257-7100 TO MAKE ARRANGEMENTS FOR PICK UP.

CONTRACTOR'S MUST NOT PLACE THEIR MATERIALS IN OUR TRASH!

PER FAIRFAX COUNTY, YARD WASTE SUCH AS GRASS TRIMMINGS, LEAVES, ETC., MUST BE PLACED OUT IN PAPER BAGS OR TRASHCANS AND CLEARLY MARKED "YARD WASTE" ON THE PAPER BAGS OR TRASHCANS.

RESIDENTS THAT DO NOT ABIDE BY THE ABOVE RULES WILL BE SUBJECT TO A BOARD HEARING AND A \$50.00 ASSESSMENT PER VIOLATION! RESIDENTS PLEASE REPORT VIOLATORS OF THE ABOVE RULES TO THE MANAGEMENT COMPANY – YOU WILL REMAIN ANONYMOUS!
