## SPRINGFIELD SQUARE RESIDENTS RECYCLYING AND YARD WASTE SCHEDULE CHANGE

## **Dear Springfield Square Residents:**

EFFECIVE THE WEEK OF MAY 13TH, RECYCLING WILL BE PICKED-UP ON WEDNESDAYS. YARD WASTE WILL BE PICKED ON REGULAR TRASH DAYS. DO NOT PUT PLASTIC BAGS IN YOUR RECYCLYING. PLASTIC BAGS IN RECYCLYING IS PROHIBITED PER FAIRFAX COUNTY. YARD WASTE MUST BE PLACED IN PAPER BAGS AND/OR TRASHCANS CEARLY MARKED "YARD WASTE" (MANDATORY PER FAIRFAX COUNTY). PURCHASE YARD WASTE PAPER BAGS AT HOME DEPOT.

## TRASH FRIENDLY REMINDERS:

- TRASH MUST NOT BE PLACED OUT IN TRASH BAGS,
- Trash must be placed out in a trashcan(s) with a secure lid (lid must be closed tight),
- The unit number must be on the trashcan(s),
- No trashcan(s) with holes / No trashcan(s) without lids,
- Recycling is picked up on Wednesday ONLY, must be in a bin/clean/NO PLASTIC BAGS,
- Trashcans & recycling bins must be removed from the Common Area on the day of service,
- DO NOT PLACE RECYCLING OUT FOR PICK-UP ON MONDAY or THURSDAY,
- Trashcans & recycling bins must not be stored in the front yard,
- YARD WASTE MUST BE PLACED OUT IN PAPER BAGS AND/OR TRASHCANS CLEARLY MARKED "YARD WASTE" (MANDATORY PER FAIRFAX COUNTY),
- Back yard trash must be in a trashcan(s) and have a secure lid (lid must be closed tight),
- Trashcan(s) may be placed out after 8:30 PM the night before pick-up. Recycling bins may be placed out after 8:30 PM the night before pick-up. Recycling must be clean and free of food residue, NO PLASTIC BAGS,
- DO NOT PLACE YOUR TRASH IN YOUR NEIGHBOR'S TRASHCAN(S), and
- <u>Unit owners with trees must clean up tree droppings from the sidewalk, streets and parking</u> spaces on the Common Area.

Please adhere to the above rules in order to comply with the community Policy Resolution Number 1. Residents that do not comply with the above rules will be subject to a Board Hearing and a \$50.00 assessment per violation. Residents please report trash violators to Northern Virginia Management – you will remain ANONYMOUS!
