

## Springfield Square Residents Trash and Recycling Holiday Schedule 2019-2020

No trash service on Thursday, Thanksgiving Day, November 28, 2019.

Trash service will resume on Monday, December 2, 2019.

No recycling service on Wednesday, Christmas Day, December 25, 2019. Make up recycling service will be provided on Saturday, December 28, 2019.

No recycling service on Wednesday, New Year's Day, January 1, 2020. Make up recycling service will be provided on Saturday, January 4, 2020.

### **FRIENDLY REMINDERS:**

- **TRASH MUST NOT BE PLACED OUT IN TRASH BAGS,**
- **Trash must be placed out in a trashcan(s) with a secure lid (lid must be closed tight),**
- **The unit number must be on the trashcan(s),**
- **No trashcan(s) with holes / No trashcan(s) without lids,**
- **Recycling is picked up on Wednesday ONLY, must be clean and in a recycling bin,**
- **Trashcans & recycling bins must be removed from the Common Area on the day of service,**
- **Trashcans & recycling bins must not be stored in the front yard,**
- **YARD WASTE MUST BE PLACED OUT IN PAPER BAGS AND/OR TRASHCANS CLEARLY MARKED "YARD WASTE" (MANDATORY BY FAIRFAX COUNTY),**
- **Back yard trash must be in a trashcan(s) and have a secure lid (lid must be closed tight),**
- **Trashcan(s) may be placed out after 8:30 PM the night before pick-up. Recycling bins may be placed out after 8:30 PM the night before pick-up. Recycling must be clean and free of food residue,**
- **DO NOT PLACE YOUR TRASH IN YOUR NEIGHBOR'S TRASHCAN(S), and**
- **Unit owners with trees must clean up tree droppings from the sidewalk, streets and parking spaces on the Common Area.**

Please adhere to the above rules in order to comply with the community Policy Resolution Number 1. Residents that do not comply with the above rules will be subject to a Board Hearing and a \$50.00 assessment per violation. Residents please report trash violators to Northern Virginia Management – you will remain ANONYMOUS!
