## NEWS

- **The parking lot will be restriped and resealed this Fall—stay tuned for details.**
- School is back in session, please drive carefully!
- TRASH – Trash is collected every Monday and Thursday.
  - Trash is still a big issue and it is difficult to identify who is setting out trash bags.
  - **Please make sure your address is on your trashcan. That way we can better identify who is not using a trashcan and address our trash issues.**
  - If you see a neighbor who is not using a trashcan, please email us. Your name will always be kept confidential.
- RECYCLING – Recycling is collected every Friday.
- YARD WASTE – **Now place yard waste with trash pickup on Mondays/Thursdays.**
  - The Fairfax County Solid Waste Management Program advises residents and collectors that the requirement for separate collection of yard waste on a weekly basis is temporarily modified for approximately two months, effective Tuesday, August 31, 2021. As of the effective date, collectors may collect yard waste with refuse (mixed collections) without enforcement consequences. The temporary change is in response to national labor shortages adversely affecting the region.
- GUEST PARKING – The Board has drafted a guest parking resolution to clarify guest parking rules. Until such time the new parking resolution takes effect please remember below are some of our current rules which will be included in the new resolution:
  - Guest parking towing hours are enforced from 10:00 p.m. to 6:00 a.m.
  - Guest parking spaces are for use by guests/visitors only and must display a **current guest parking tag with the guest parking tag number clearly visible.**
  - If you are in violation of these rules, a notice will be sent to the lot owner as a reminder that a vehicle associated with the lot owner's guest parking tag has been parking in violation.
