2025/2026 Holiday Trash Schedule:

Thanksgiving Day, Thursday, November 27, 2025; Christmas Day, Thursday, December 25, 2025, and New Year's Day, Thursday, January 1, 2026, TRASH WILL BE PICKED UP ON FRIDAY, THE DAY AFTER EACH HOLIDAY (place trash out Thursday night after 8:30 pm).

TRASH POLICY REMINDERS:

Picked-up on Monday and Thursday mornings. All units are required to use a trashcan(s) with a secure lid, and house number on each trashcan(s); no trashcan(s) with holes/no trashcan(s) without lids. Trash may only be placed outside AFTER DARK (8:30 PM or later) Sunday and Wednesday evenings or by 6:00 AM on the morning of the pick-up.

- **TRASH MUST NOT BE PLACED OUT IN TRASH BAGS - NO TRASH BAGS of any kind are permitted.**
- **Do not place your trash in another unit's trashcan.**
- **Do not place trash out after the trash has been picked-up.**
- **Overflowing trashcan(s) results in a \$50 assessment - obtain additional trashcans to comply.**
- **Bulk items and white goods such as, but not limited to washers, dryers, stoves, TV's refrigerators, furniture, etc., you must call Patriot @ (703) 257-7100 to arrange a pick-up.**
- **Contractor's trash/materials must be removed by the contractor-not placed in our trash!**
- Trashcans and recycling bins **MUST** be removed from the Common Area on the day of pick-up.
- Trashcans and recycling bins not removed on the day of pick-up will be removed.
- Trashcans and recycling bins **must not** be stored in the front yard.
- **Back yard trash must be in a trashcan(s) with a secure lid (lid must be closed tight).**
- **Trash sites are randomly monitored/report trash violators to NVM/you will remain anonymous.**
- **Trash violations result in a \$50 assessment per violation.**

RECYCLING POLICY REMINDERS:

Recycling is picked-up on Wednesday ONLY! Recycling may only be placed outside **AFTER DARK (8:30 PM or later)** on Tuesday evenings or by 6:00 AM on Wednesday morning.

- Place recycling in a recycling bin.
- **DO NOT PLACE RECYCLING IN PLASTIC BAGS. The recycling provider will no longer pick up plastic bags and if they leave your plastic recycling bags, you will be subject to a \$50 trash violation.**
- Do not place recycling out for pick-up on Monday or Thursday.
- **RECYCLE ONLY:** clean paper/cardboard (break down boxes to flatten); clean plastic bottles & containers/clean metal cans.
- **DO NOT RECYCLE:** plastic bags/wrap/wrappers; glass bottles, jars or broken glass; light bulbs; Styrofoam; packing peanuts; tin foil; dirty pizza boxes, take-out food and beverage containers and anything dirty or with food.
- **Take plastic bags to the grocery store.**
- **Take glass bottles, jars and broken glass to the Franconia Police Station (bin outside).**

YARD WASTE REMINDERS – MANDATORY BY FAIRFAX COUNTY:

Yard waste must be placed in PAPER BAGS or a TRASHCAN clearly marked "Yard Waste" on both sides and placed out on Saturday morning by 6 am.

Please adhere to the above rules in order to comply with the community trash and recycling Policy Resolution Number 1. Residents that do not comply with the above rules will be subject to a virtual Board Hearing and a \$50.00 assessment per violation.
